Why We're Different



Getting Certified



Experience

Applicant must complete and document one-hundred (100) hours of experience working or volunteering directly with youth (classroom, one-on-one, small group, counseling, program facilitation, etc.) Applicants may complete their 100 hours of experience while pursuing their certification.



Coursework

The following EyesOpenIowa courses are required for initial certification:

- -Awkward to Awesome: Core Skills
- -Sex Ed Staples: Core Content
- -Four (4) Additional Hours of trainings are required for certification.

Capstone

Each individual in pursuance of CSHE certification will complete a project that showcases the applicants skills as a sexual health educator. The capstone project is one that increases learner outcomes, empowers youth, and or advocates for populations served. Projects must be approved by EyesOpenlowa staff before they have begun. Cost

Cost for certification, after fees for required coursework are paid, is \$600.

This \$600 fee provides applicants with all of the benefits listed on page 3, including individualized coaching and exclusive content. We know many educators are investing in this certification from their personal budget, with that in mind we hope to make this opportunity accessible. Payment can be made in full or inquire for customized payment plans to meet your needs. We are happy to work one-on-one with individuals or organizations to develop payment plans that work within your budget.

Recertification

Recertification is simple and easy!

Continue to evolve in your career and keep recieving the best education possible.



Cost for Recertification is \$150

Initial Certification is good for two years, and most educators choose to re-certify after that time.

After initial certification is received, CSHE educators are required to obtain 16 hours of CSHE-eligible EyesOpenIowa trainings.

In addition, CSHE's seeking recertification are required to complete a check-in survey and phone call with a training department staff member in order to best serve CSHE's in the future. We'll check in with you to make sure your personal information is up to date, learn how you've grown in your career, and address areas for growth.

In the event of the program being discontinued, certification would remain in effect for the full period of certification.

Participants may appeal denial of certification by sending a written request for an appeal review meeting within thirty (30) days of receipt of notice of denial. The request should be addressed to

An appeal meeting shall be held at a time and place mutually agreed upon by EOI and the applicant. This appeal meeting will be facilitated by EOI staff and closed to the public. If an applicant has requested an appeal meeting, and upon whom proper notice of the meeting has been served, fails to appear for the meeting, EOI will continue with the review and the applicant will be bound by the results to the same extent if the applicant has been present.
